What your future holds...

Exactly what is your vision? I say a prayer to God asking for clarity and guidance for the person I am about to read. I then see a "film" of the person I'm reading in their everyday life.

What do you think about business in Arizona? If you were given one million dollars, what is the first thing you would do? I was a millionaire and shopaholic. When I divorced, my husband had hidden everything in offshore accounts. After two years of legal fees and court dates I walked away from it all. It was better to put my energy into myself. If I had it again, I would use it more for basic necessities that my children have had to do without.

If you weren't in your current job, what would you be doing? Join the Peace Corps and help Third World countries. I can't imagine not using my psychic ability, it's my life.

What is your key to happiness? Being of service to others by using my psychic abilities. It gives me a chance to get out of myself.

Any love advice? Set a standard and don't lower it. Do not get physically involved with anyone until you see if they walk their talk.

Motto? Be afraid and go for it anyway.

How do you make your predictions? I tune something in by asking a question in my head, then I get an answer. I follow it like a calendar. I see things as if I'm watching a movie with the thoughts, feelings, and visual of the people I am tuning in. I get things in detail.

What was your position on the O.J. case? I think he is guilty. For 12 weeks I gave a psychic perspective on a weekly basis on the case for a national tabloid.

Do you look at cases as they surface, such as the Jon Benet case? Usually when I'm done with clients for the day, I spend time with their kids. I try to give back my gift by doing some gratis work. I have volunteered some time with Search and Rescue and worked on a couple of murder cases with the police. I have spoken at the SYDS Foundation and grieving groups to help people find closure for the loss of loved ones. I am a great medium.

What are your thoughts on bin Laden? He's not the top man, he's merely a scapegoat. I believe he is part of a larger organization.

Have you seen terrorism coming? Honestly, I predicted it, but I was off on the timing. I thought it would occur a year ago and didn't expect it would happen in this way. In fact, last year I took precautions by purchasing survival gear.

Any global predictions? Because of what's going on with the Euro, I thought I'd see if our currency is going to change. In either 2003 or 2004 we're going to have a change in currency. I had a dream about getting money out of the bank. Next, I think we're going to have a stock market crash at the end of spring or the beginning of summer this year.
